## **TNAI – HEE MoU to Smoothen Nurses' Placement Abroad**

s part of strengthening TNAI's role as placement agency for deploying nursing personnel, an MoU was signed with Health Education England (HEE) for Nurses' recruitment to UK under Global Learners Programme (GLP). The signatories on TNAI side were Prof (Dr) Roy K George-President and Mrs Evelyn P Kannan- Secretary General; on Health Education England side were its Director Prof Ged Byrne, and HEE Country lead in India Mr Ed Rose.

The main features of this fully free arrangement include: Nurses will get the updated skills from the NHS employers, Tier 2 work visa including family visa, free IELTS/ OET and CBT training, GLP certificate and renewal facility from the employer after completion of the contract, three months' free accommodation. The HEE delegation also visited the TNAI's National Skills Lab and AHA-approved International Training Centre in Greater Noida. Possibilities of collaboration in other areas between the two organisations was also discussed.

A significant event of the month of particular interest of nurses is the Newborn Care Week celebrated annually in the country during 15 to 21 November. Labour, birth and the immediate postnatal period are the most crucial factors for newborn and maternal survival. Unfortunately every year some 2.6 million babies die in the first 28 days of life (neonatal period that carries the highest risk), besides additional 2.6 million stillbirths. About three-fourth of neonatal deaths can be prevented with available effective health measures provided at birth and during the first week of life. The programmes during the Newborn Care Week seek to raise awareness about the importance of the newborn care for child survival and development. Although the Neonatal Mortality Rate (NMR) has declined from 44 per 1000 live births in 2000 to 28 per 1000 live births, the goal of reducing under-five mortality to 20 or less per 1000 live births by 2035 can only be met with dedicated efforts to reduce newborn mortality.

World Diabetes Day (WDD) on 14 November alerts us to the growing menace of diabetes and the varied health threats it entails. Organised at the instance of World Health Organisation and Interna-

# निहायत जरूरी है बच्चों का टीकाकरण

आज विश्व में बहुत सी मौतें इसलिए होती हैं कि बच्चे को फलां बीमारी का टीका नहीं लगाया गया था। हालांकि छोटे बच्चों में आंशिक तौर पर बीमारियों के प्रति कुदरती इम्यूनिटी रहती है किंतु यह काफी नहीं, और उन्हें संस्तुति के अनुसार टीका लगवाना निहायत जरूरी होता है। बाल टीकाकरण कार्यक्रम के तहत कवर की गई सात जानलेवा बीमारियां हैं डिफ्थीरिया, काली खांसी, टिटेनस, पोलियो, टीबी, खसरा, और हिपैटाइटिस–बी।

डब्लूएचओ के अनुसार टीकाकरण जानलेवा बीमारियों से निजात पाने का सबसे किफायती, सिद्ध उपाय है, इससे 20 से 30 लाख जानें बच सकती हैं। अफसोस यह है कि 1.90 करोड़ बच्चे टीके लगने से छूट जाते हैं। टीकाकरण मुहिम को प्रभावी बनाने की दृष्टि से 10 नवंबर का दिन विश्व टीकाकरण बतौर मनाया जाता है। इस दौरान टीकाकरण की भूमिका, इससे जुड़ी भ्रांतियों का निराकरण, सही टीकाकरण विधियों आदि के बाबत जागरूकता सवंर्धित की जाती है। डब्लूएचओ 24–30 अप्रैल वाले सप्ताह में प्रतिवर्ष विश्व टीकाकरण सप्ताह आयोजित करता है।

हालांकि सार्वजनीन टीकाकरण कार्यक्रम (यूआईपी) 1985 से चालू है किंतु इसे अधिक गति देने के लिए चुनींदा जिलों के सभी बच्चों को टीकाकृत करने की मुहिम मिशन इंद्रधनुष दिसंबर 2014 में को शुरू की गई थी। इसी मुहिम के चलते करीब चार साल पहले पोलियो के मामले लगभग शून्य हो गए थे। हमारे देश में टीकाकरण की निःशुल्क सुविधा सभी सार्वजनिक अस्पतालों, स्वास्थ्य केंद्रों, आईसीडीएस केंद्रों में उपलब्ध है। कार्यक्रम की मानीटरिंग प्रधानमंत्री कार्यालय द्वारा की जाती है। मिशन के तहत गर्भवती महिलाएं भी शामिल हैं।

# सामुदायिक स्वास्थ्य नर्सिंग प्रक्रिया

नर्सिंग प्रक्रिया, नर्सिंग गतिविधियों का सार है। यह आज के नर्सिंग की अति महत्वपूर्ण, और मान्य वैज्ञानिक पद्धति में है। नर्सिंग प्रक्रिया जरूरतों की आपूर्ति और रोगियों की समस्याओं को हल करने के लिए नियोजित कदमों और कार्यों की एक श्रंखला को इंगित करता है। नर्सिंग प्रक्रिया नर्सिंग के अभ्यास के लिए रूपरेखा प्रदान करती है।

### नर्सिंग प्रक्रिया के प्रकार

नर्सिंग प्रक्रिया का उपयोग देखभाल के स्तर पर किया जा सकता है।

• व्यक्तिगत नर्सिंग प्रक्रिया के तहत अलग–अलग नर्सिंग प्रक्रिया को समस्या का हल करने के लिए व्यवहार में लाते हैं। यह सबसे अधिक इस्तेमाल की जाने वाली नर्सिंग प्रक्रिया है।

### सामुदायिक स्वास्थ्य नर्सिंग प्रक्रिया के उद्देश्य

1) समुदाय की वास्तविक या संभावित स्वास्थ्य समस्याओं / स्वास्थ्य देखभाल आवश्यकताओं की पहचान करना।

- 2) पहचान की गई सामुदायिक स्वास्थ्य आवश्यकताओं को पूरा करने के लिए नर्सिंग कार्यनीति तैयार करना।
- 3) जरूरतों को पूरा करने के लिए नर्सिंग हस्तक्षेप देने के लिए।
- 4) समुदाय में प्रदान की गई नर्सिंग देखभाल का मूल्यांकन करना।

### सामुदायिक स्वास्थ्य नर्सिंग प्रक्रिया का महत्व

(1) समुदाय उन्मुख देखभाल जारी रखना (2) समुदाय में उपलब्ध संसाधनों का अधिकतम उपयोग (3) सामुदायिक स्वास्थ्य टीम के कामकाज में सुधार (4) सामुदायिक स्वास्थ्य नर्सों की नौकरी से संतुष्टि (5) सामुदायिक स्वास्थ्य नर्सों की पेशेवर संवृद्धि (6) सामुदायिक स्वास्थ्य नर्सिंग में गुणवत्ता आश्वासन (7) सामुदायिक स्वास्थ्य की स्थिति में सुधार।

### सामुदायिक स्वास्थ्य नर्सिंग प्रक्रिया के चरण

- 1– समुदाय की पहचान
- 2– जनसंख्या संरचना को जानना
- 3– स्वास्थ्य और संबद्ध संसाधनों का पता लगाना

4– नर्सिंग प्रक्रिया लागू करना (क) सामुदायिक स्वास्थ्य नर्सिंग मूल्यांकन (ख) सामुदायिक स्वास्थ्य नर्सिंग निदान (ग) योजना (घ) कार्यान्वयन (सामुदायिक स्वास्थ्य नर्सिंग देखभाल सेवाएं) (च) मूल्यांकन।

क) सामुदायिक स्वास्थ्य नर्सिंग मूल्यांकन – यह एक संगठित और व्यवस्थित तरीका है, जिसके लिए पहचाने गए समुदाय का आकलन करते हैं। इसकी तीन अवस्थाएं हैंः स्वास्थ्य की स्थिति का निर्धारण; उन संभावित जोखिम कारकों की पहचान जिनसे स्वास्थ्य पर बुरा असर पड़ सकता है; समुदाय में मौजूद स्वास्थ्य समस्याओं का पता लगाना। सामुदायिक स्वास्थ्य नर्सिंग मुल्यांकन पर निम्नलिखित शीर्षकों के तहत चर्चा की जा सकती हैः

डेटा संग्रह और व्याख्याः डेटा एकत्र करना, जो वर्तमान में उपलब्ध डेटा को प्राप्त करने की प्रक्रिया है। इनमें शामिल हैं जनसांख्यिकीय डेटा (आयु, लिंग, सामाजिक–आर्थिक, धर्म या नस्ल संबधी जानकारी आदि); महत्वपूर्ण आंकड़ा (शिशु मर्त्यता, मातृ मर्त्यता, जीवन प्रत्याषा, अन्य मृत्यु दर और रुग्णता डेटा); संस्थागत डेटा (स्वास्थ्य संगठन, सेवाएं प्रदान करना और स्वास्थ्य, जनशक्ति विशेषताएं आदि)।

 ♦ डेटा प्राप्तिः कुछ डेटा आसानी से उपलब्ध नहीं होते। इस तरह के डेटा को सामुदायिक स्वास्थ्य नर्स या किसी भी डेटा कलेक्टर द्वारा सामुदायिक समूहों या सदस्यों के साथ बातचीत के माध्यम से विकसित किया जाता है। उदाहरण हैं
– मूल्यों और अनुष्ठानों, परंपराओं और रीतिरिवाजों का ज्ञान और जानकारी, सरोकारों, समस्याओं को सुलझाने की प्रक्रिया, नेतृत्व, सांस्कृतिक प्रभाव, जाति–वर्ण, राजनीतिक दबाव आदि।  आंकड़ों की विवेचनाः डेटा व्याख्या प्रक्रिया का तात्पर्य है, विश्लेशण करना, संश्लेषण करना, उन्हें सहेज कर रखना, सामुदायिक स्वास्थ्य समस्याओं और प्रभावी और उपलब्ध संसाधनों की पहचान करना।

डेटा मूल्यांकन और व्याख्या के उपकरण

- जानकारीपूर्ण साक्षात्कार
- प्रतिभागी अवलोकन
- मौजूदा डेटा का द्वितीयक विश्लेषण (सेकेंडरी एनालिसिस)
- विंड शील्ड सर्वेक्षण।

(ख) **सामुदायिक स्वास्थ्य नर्सिंग निदान** – सामुदायिक निदान दोनों विषयों का दायरा है, महामारी विज्ञान और नर्सिंग। दोनों समुदाय की स्वास्थ्य समस्याओं की पहचान करने और समुदाय की स्वास्थ्य आवश्यकताओं की प्राथमिकताओं को स्थापित करने का प्रयास करते हैं। समुदाय में निम्नलिखित समस्याएं मौजूद हो सकती हैं-1) सीधे स्वास्थ्य और इसके विभिन्न घटकोंसे संबंधित समस्याएं: कम वजन का शिश्, शिशू कुपोषण, मलेरिया आदि। 2) स्वास्थ्य सेवा प्रणाली की समस्याएं: स्वास्थ्य देखभाल एजेंसियों की कमी. स्वास्थ्य कर्मियों और संसाधनों की कमी. स्वास्थ्य संस्थानों का असमान वितरण असंतोषजनक संदर्भ सेवाएं आदि। 3) आईईसी से संबंधित समस्याएं: जागरूकता और जानकारी की कमी, दोषपूर्ण मीडिया प्रबंधन, अनुचित संचार साधन, त्रुटिपूर्ण स्वास्थ्य शिक्षा, अपर्याप्त परिवहन सुविधाएं आदि। 4) स्वास्थ्य को प्रभावित करने वाली आम समस्याएं शिक्षा की निम्न स्थिति, बेरोजगारी, भीडभाड वाली कम्युनिटी, दुभर क्षेत्र, ध्वनि, वायू, जल आदि का प्रदूषण, लचर निपटान प्रबंधन, प्राकृतिक आपदाएं, गरीबी, बच्चों और महिलाओं से दुर्व्यवहार, अपर्याप्त जल आपूर्ति। ग) **योजना**– 1) सामुदायिक स्वास्थ्य समस्याओं के बीच प्राथमिकताओं का विश्लेषण और उनकी स्थापना। 2) लक्ष्य और उद्देष्य सुनिश्चित करना। 3) हस्तक्षेप की पहचान। घ) **कार्यान्वयन** यह नर्सिंग प्रक्रिया का चौथा चरण है जिसका उद्देष्य नर्सिंग क्रियाओं या गतिविधियों को संचालित करना है । कार्यान्वयन को प्रभावित करने वाले कारक 1) नर्स की भूमिकाः वह सामग्री विशेषज्ञ, परामर्शदाता, स्वास्थ्य शिक्षक आदि हो सकती है जो सामुदायिक स्वास्थ्य देखभाल देखभाल कार्यान्वयन को प्रभावित करती है। 2) स्वास्थ्य समस्या के प्रकार का चयन। 3) समस्या समाधान में भाग लेने के लिए सामुदायिक तत्परता। 4) सामाजिक परिवर्तन की प्रक्रिया के लक्षण। कार्यान्वयन के तरीके 1) छोटे अंतःक्रियात्मक समूह। 2) सलाहकारों को रखना। 3) मास मीडिया या संचार के साधन। 4) स्वास्थ्य नीति और सार्वजनिक स्वास्थ्य कानून। च) मूल्यांकन – सामुदायिक स्वास्थ्य नर्सिंग प्रक्रिया के मूल्यांकन में मुख्य रूप से दो पहलू शामिल हैं: नर्स के प्रदर्शन का मुल्यांकन और समुदाय में व्यवहार परिवर्तन का मुल्यांकन। इसके तहत लक्ष्यों के संदर्भ में मुल्यांकन, योजना कार्रवाई और

अनुवर्ती मूल्यांकन आते हैं।



# **Guidelines for Authors**

The Nursing Journal of India (NJI) invites contributions for publication including original research article, case studies, review articles, that may be relevant/related to Nursing Practice, Management, Education.

The articles should follow the following sequence: Title; Name(s) of author(s) with designation; Complete address for correspondence; Abstract (in research articles); Introduction or background; Literature Review (in Short); Methodology; Results and Discussions; Conclusion; References-recent references (5-10) should be used. Ideally, the articles should be 1500 to 2000 words long. Illustrations, diagrams, photographs should be preferably in black and white; if in colour, these should have good reproducibility.

Authors should send the soft copy through mail along with a cover note addressed to the Editor, NJI. The cover note should: (i) indicate the TNAI Membership number; (ii) mention the year in which the study was conducted; (iii) furnish an undertaking that the article has not been submitted elsewhere for publication.

After lengthy discussion the members suggested to add the following along with existing guidelines for authors:

- 1. Institution Ethical Clearance(IEC) letter to be obtained from the hospital/institutions by the authors whoever conducting interventional studies.
- 2. Order of authorship should be mentioned by the authors.
- 3. If more than one authors for research article, only author name to be mentioned and rest of the authors names can be mentioned at the bottom of the page.
- 4. References should be numbered and should stick to the Vancouver style.
- 5. In case of websites: mention the retrieval date.
