The TNAI's 29th SNAI Biennial Conference, first time the virtual way because of the still lingering Coronavirus, was conducted befittingly on 21-22 January 2022 with WHO as Conference partner. About three lakh participants attended the Conference, quite many of them joined via YouTube. Goodwill messages for the event were received from Hon'ble Vice President, Prime Minister, Health Secretary, Chief Nursing Officer WHO, President CNMF, Executive Secretary CNMF and President INC. Special highlights of the Conference were the online Quiz competition and the launch of WHO's Safe Abortion Values – Evidences & Rights (SAVER) game. The academic and cultural inputs together made it a memorable event. The enthusiasm demonstrated by students in the Conference once again confirmed that the nurse students are willing and committed to keep learning and growing professionally, a good sign for one and all. We congratulate all the student nurses who vibrantly participated in this historical event.

The health care delivery system in any country is primarily dependent on the quality of services nurses discharge. The student nurses have enormous potential that can be channelised for the benefit of community. That is why at TNAI we have been endeavouring to groom the student nurses the best way, through training, upskilling and otherwise. The SNA wing of TNAI precisely works in this direction.

The New SNAI Plan: Ever since introduction of SNAI new plan in 2016, consistent increase is being witnessed in the number of SNAI units adopting new plan. So for 551 units have adopted this plan; that covers 79,801 BSc (N) students, 39,698 GNM students and 5,819 ANM students, i.e. a total of 1,25,318 students have opted this plan. As a token of appreciation, it has been decided to facilitate the SNAI with Laerdal Skill Modular having adopted the new SNAI Plan for last five years and the uterine collection Manikins to the units who adopted it continuously for three years.

- 1. Last date for receiving Nominations is **17 April, 2022** (6 weeks from the date of Publication)
- 2. The election venue, date and time will be informed to you well in advance.
- 3. Both the nominator as well as nominee shall be a life member of TNAI.
- 4. The members holding office positions in TNAI shall not hold office positions in parallel Nursing Organizations and vice versa. For acquiring the new post the members will have to relinquish the former post.
- 5. A member working and residing in a state or Union Territory shall be the member of the branch of TNAI. In case of temporary change of resident e.g. study; deputation etc. for a period of more than a year, the member shall be given an option for changing his/her membership to the temporary place of resident after informing the headquarters and the former and latter state branches.
- 6. The nominator and Nominee should be working and residing in the same state or Un-

- ion Territory shall be eligible for contesting election and casting the vote.
- 7. The members who are residing outside the country and state shall not be eligible for contesting election.
- 8. Members who are or had been involved in litigation with the Association without first representing the grievances to the grievances committee shall not be eligible to contest and shall have no voting rights and same will be applicable to the members who are facing disciplinary proceedings in their work situation/sphere.
- 9. Outgoing office bearers who completed one term shall be eligible for re-election for one more term.
- 10. Any life member of TNAI may make nominations for all the offices of the TNAI State/ UT Branch, but the nomination for the President and Secretary shall be made only from those who have served for one term (four years) as the EC members/office bearers at any time.
- 11. A break of four years after two consecutive terms (8 years) is necessary for the President/Secretary of the branch.
- 12. For the offices of President and Secretary all valid nominations shall be included in the Provisional Ballot Paper. For other offices the names of three members having highest number of nominations shall be included in the Ballot Paper.
- 13. The Chairperson of the Public Health Nursing Section, Nursing Service Section, Education Section and Representatives of Health Visitor's League (HVL)/ANM should be elected from their respective field only.
- 14. The nomination Sheet duly filled and completed by the nominator i.e. complete address, TNAI number along with the signature shall be sent to the Returning Officer within six weeks of its publication in the TNAI Bulletin.

National e-governance Award 2020-21

The National e-governance Award 2020-21 under Category of IV-Outstanding research on citizen centric services in Academic/Research institutions was awarded to the ICMR funded project with team members of Dr. L Gopichandran, Associate Professor, College of Nursing, AIIMS, New Delhi and Principal Investigator of ICMR project titled "A randomised controlled trial to compare the efficacy of mobile app vs conventional prescription



of analgesics and adjuvants on adherence and selected variables among cancer patients receiving palliative care at a tertiary care centre" during 24th National Conference on Friday, 7th January 2022.

The prestigious award was presented by Dr Jitender Singh, Union Minister of the state, Govt of India. The project was done at the Department of Onco-Anaesthesia and Palliative Medicine, Dr BRAIRCH, AIIMS, New Delhi. The mobile application enabled patients to improve the medication adherence by utilising the app features such as reminder alarms, drug information, symptoms scoring, etc. This also helped the palliative care physicians and nurses to follow up and track patient status including pain, constipation, nausea, vomiting, etc and thus improving the overall quality of life of the patient.

Author Guidelines

The Nursing Journal of India is a nursing journal with National and International circulation. It publishes original communications of nursing research that advance or illuminate Health science, that educate the journal readers. It is published bimonthly.

The NJI strongly discourages duplication/reduplication of data already published in other journals (even when certain cosmetic changes/additions are made). If and when duplication is detected after publishing in NJI, the journal will be forced to 'retract' such articles.

EDITORIAL PROCESS

- Copy Right: Authors need to certify in the covering letter that this manuscript has not been published elsewhere/submitted to any other journal simultaneously for consideration.
- Manuscripts are screened initially at the editorial office for suitability of publication. Those found
 provisionally suitable are sent to three peer reviewers. The journal follows the double blind peer
 review process.
- After peer review process, selected manuscripts for publication are edited before publication.
- The processes of submission of manuscript, peer review, communication of final decision and sending proofs are managed through online platform.

SUBMISSION OF MANUSCRIPT

All manuscripts submitted for publication to the NJI should include the following:

- 1. Cover page file
- 2. Article file including tables and figures
- 3. A scanned copy of ethical clearance certificate
- 4. Undertaking by authors & copyright transfer agreement
- 1. Cover Page File: Covering letter should include (i) name(s) of author(s); (ii) TNAI number; (iii) Educational qualification (iv) Designation of authors; (v) complete postal address, mobile number and e-mail id of all authors; (vi) name of corresponding author with all above mentioned details. (vii) Title of the article/Problem Statement. It should be addressed to the Chief Editor, NJI at The Trained Nurses' Association of India L-17 Florence Nightingale Lane, Green Park New Delhi-110016.
- 2. Article File: Manuscripts must be submitted online through the website: https://review.jow.med-know.com/ijmr. First time users will have to register at this site. Registration is free but mandatory. Registered authors can keep track of their articles after logging into the site using their user name and password. Manuscripts should be presented in concise form within the word limits of 2000-2500 maximum. Pages should be numbered consecutively and the contents arranged in the following order:

Sequence of Research Article (Maximum 2000-2500 words)

- I. Title: The title of manuscript shall not exceed 15 words, shall be given on top of the title page. Information regarding authors shall be given in a separate page which shall include the following; Name, Academic degree, Designation/position, name of Institution. Address for correspondence including telephone number & email. In case of group of authors the names shall be listed in the order of authorship. Cover letter should include statements regarding authorship.
- **II. Abstract and Key Words:** The abstract must be in one-paragraph with self-contained summary of the most important elements of the paper. The abstract shall not exceed 250 words. All numbers in the abstract (except those beginning a sentence) should be typed as digits rather than words.


- **III. Introduction:** It shall be 3-4 paragraphs which consists of brief background of the problem studied, critique of relevant research articles that are referenced as per Vancouver/ APA style. Clearly state the purpose / objectives and hypotheses tested.
- **IV. Materials and Methods:** It should highlight the setting where the study was done, sample size and method of selection. A brief description of the demographic variables of the sample could be provided in 2-3 sentences. It should also have a description of the design, tools/ instruments used for collecting data; ethical approval and ways by which privacy and confidentiality of subjects were maintained; how data were collected; pilot study (if done) with any modifications made thereof and any methodological limitations.
- **V. Results:** It must be presented in a logical sequence. Only such data as are essential for understanding the discussion and main conclusions emerging from the study should be included. Data presented in tables and figures should not be repeated in the text. Only important observations need to be emphasized or summarised. The same data should not be presented both in tabular and graphic forms. Interpretation of the data should be taken up only under the Discussion and not under Results.
- **VI. Discussion:** The discussion should deal with the interpretation of results without repeating information already presented under Results. It should relate new findings to the known ones and include logical deductions. The conclusions can be linked with the goals of the study but unqualified statements and conclusions not completely supported by the data should be avoided. Recommendations may be included as part of the Discussion, only when considered absolutely necessary and relevant.
- **VII. References:** The total number of References should normally be restricted to a maximum of 20.
- **VIII. Illustrations:** Illustrations must be electronically prepared and we prefer them in soft copy either by mail / disc. Tables and figures must be numbered.
- **IX.** Acknowledgement of Receipt: The decision of acceptance/ rejection/ recommendation for resubmission will be intimated to the corresponding author.
- 3. ETHICAL CLEARANCE CERTIFICATE: All research articles submitted shall be accompanied by a copy of certificate issued by the institutional ethical committee
- **4. UNDERTAKING BY AUTHOR(S) Downloadable form:** It is necessary that all the authors give an undertaking (in the format specified by the journal) indicating their consent to be co-authors in the sequence indicated on the cover page. All authors must sign the undertaking letter.

भारी पड़ सकती है किडनी रोग के प्रति कोताही

शरीर की सेहत के लिए अत्यावश्यक है कि विभिन्न शारीरिक क्रियाओं के दौरान उत्पन्न हानिकारक अपशिष्टों और अतिरिक्त पानी को बाहर निकाल दिया जाए। यह कार्य सुषुम्ना की पसलियों के नीचे स्थित दो किडनी करती हैं। ये सुचारु रूप से कार्य न करें तो शरीर का रासायनिक बिगड़ जाता है।

किड़नी की कार्यप्रणाली विकृत होने को क्रॉनिक किड़नी डिसीज़ (सीकेडी) कहते हैं। सीकेडी का अर्थ है कि आपकी किड़नी खराब है और ब्लड़ को सही तरीके से फिल्टर नहीं कर सकती है। इनका मुख्य काम है यूरिन बनाने के लिए आपके रक्त से अपशिष्टों और अतिरिक्त पानी को फिल्टर करके बाहर निकालना। ये शरीर का रासायनिक संतुलन भी बनाए रखते हैं, ब्लड़ प्रेशर कंट्रोल करने में सहायता करते हैं और हार्मीन बनाते हैं। किड़नी ब्लड प्रेशर कंट्रोल करने में सहायक होती है, हार्मीन भी निर्मित करती है। डायबिटीज़ और हाई ब्लड प्रेशर सीकेडी का सबसे बड़ा कारण किड़नी का कार्य अवरुद्ध होना है।

क्रॉनिक किडनी रोग के आम लक्षण हैं अनीमिया (यानी खून की कमी); मूत्र का रंग गहरा होना, इसकी मात्रा कम हो जाना, मूत्र में रक्त आना, जल्दी जल्दी (विशेषकर रात में पेशाब आना); भूख कम लगना; पैर, हाथ या टखने (कभी चेहरे में भी) में सूजन; थकान; हाई ब्लड प्रेशर; त्वचा में लगातार खुजली होना; मांसपेशियों में एंठन; जी मचलना, मांसपेशियों में झनझनाहट आदि।

किड़नी को खराब होने में कई वर्ष लग जाते हैं। कई लोगों को बीमारी बहुत गंभीर होने से पहले पता नहीं चलता है। इसका एक कारण यह भी है एक किड़नी स्वस्थ हो तो भी शरीर भलीभांति कार्य करता रहता है। मूत्र और खून की जांच से इसका पता लगाया जा सकता है। उपचार के लिए ब्लड प्रेशर घटाने, ब्लड ग्लूकोज कंट्रोल तथा ब्लड कोलेस्ट्रॉल कम करने की दवाएं दी जाती हैं। सीकेडी की वजह से किड़नी ज्यादा खराब होने पर एकमात्र उपचार डायलिसिस या किड़नी प्रत्यारोपण है।

बचाव कैसे करें

विश्व में करीब 17 लाख व्यक्ति सीकेडी के कारण जान खो बैठते हैं। वैश्विक स्थिति की भांति संप्रति देश में भी लगभग 14 प्रतिशत व्यक्ति किडनी रोगों से जूझ रहे हैं। चरम सीमा तक पहुंचने पर प्रत्यारोपण (ट्रांस्प्लांटेशन) के सिवाए विकल्प नहीं रहता जो न केवल खर्चीला है (करीब 8-10 लाख रुपए) किंतु मैचिंग किडनी मिलना दुष्कर होता है। अतः बीमारी के रोकथाम पक्ष पर ध्यान देना चाहिए।

आहार नियमित और पौष्टिक हो, इसमें फल और सब्जियां, साबुत अनाज, बिना चर्बी वाला मांस-मछली आदि प्रचुर मात्रा में हों तािक ब्लड प्रेशर नियंत्रित रहे। उपयुक्त आहार के सेवन से डायबिटीज़ और हृदय रोग जैसी दीर्घकालीन बीमारियां के आसार भी घटते हैं। सीकेडी से बचाव के लिए शारीरिक व्यायाम को सर्वाधिक कारगर माना गया है। प्रत्येक व्यक्ति को चाहिए कि वे अपनी उम्म, वजन और स्वास्थ्य के लिए अनुसार जानकारों द्वारा बताए व्यायाम नियमित तौर पर करे। इसके अतिरिक्त मादक पदार्थों, नशीली दवाओं और धूम्मपान का सेवन न किया जाए; लीड जैसी भारी धातुओं के संपर्क में रहने से यथासंभव बचा जाए। एंटीइन्फ्लेटरी दवाओं और दर्दनिवारकों का उपयोग चिकित्सकीय देखरेख में किया जाए, डाक्टरी सलाह से नियमित अंतराल पर जरूरी जांचें करवाई जाएं। सीकेडी के प्रति जागरूकता उत्पन्न करने की दृष्टि से इंटरनेशनल सोसाइटी ऑफ नेफ्रोलोजी और इंटरनेशनल फेडरेशन ऑफ किडनी फाउंडेशन के संयुक्त तत्वाधान में प्रतिवर्ष मार्च के दूसरे बृहस्पतिवार (इस वर्ष 10 मार्च) का दिन विश्व किडनी दिवस बतौर मनाया जाता है।

World Kidney Day: 10 March

One of fastest growing diseases the world over, chronic kidney disease (CKD) is a challenge for health planners and laymen. It is the eighth leading cause of death. In India, one in every seven persons is living with this complicated condition. Diabetes, raised potassium level, anaemia, heart disease, decreased sex drive, damage to central nervous system and hypertension complicate the issues with kidney. In the terminal stage, called end-stage renal disease, the kidneys are disabled to remove enough wastes and unwanted excess fluids from the body and dialysis (usually twice or thrice a week) is often the only option. If that too does not work, kidney transplant, a costly and cumbersome proposition, is the only way. Increasing incidences of diabetes and hypertension tend to raise the CKD cases.

World Kidney Day on 10 March (second Thursday of March every year) is a joint initiative of the International Society of Nephrology and the International Federation of Kidney Foundations. Behind the campaign is the need to raise awareness about the kidneys and reducing the frequency and impact of kidney disease together with associated health problems, worldwide. The campaign is conducted annually in more than 100 countries.

Many factors go into the high prevalence of CKD in our country, these include: type 1 or type 2 diabetes; hypertension; inflammation of the kidney's filtering units or tubules and surrounding structures; prolonged obstruction of the urinary tract due to enlarged prostate, kidney stones; or recurrent kidney infection. Trend of consuming the fast and ultra-processed food also put additional pressure on the kidneys thus affecting its functioning.
