Orientation Programme for Assam State Branch Executives

In line with the decision at the TNAI's EC meeting (in 2019) to orient the TNAI State & UT Branch Executive Committee members to the functioning of TNAI within three months of State /UT Branch Election, the executive members from Rajasthan State branch participated in the one-day orientation programme on 23 March 2024 at TNAI Headquarters and its Greater Noida campus. - X. Chairperson Public Health Nursing Section (Public Health Nursing Personnel only eligible)
- XI. Chairperson- Nursing Service Section (Hospital/ Clinical Nursing Personnel only eligible)
- XII. Chairperson Socio-Economic Welfare Committee
- XIII. Chairperson LHV/ ANM, State Branch (Only LHV/ANM personnel eligible)

2. Common Eligibility Criteria for the State/ UT Branch Office Bearers

- i. Any candidate filing nomination for State/ UT Offices shall have completed a minimum of **05 years** of membership in TNAI.
- ii. Age: Shall not have completed **66 Years as of 1st of January** of the calendar year in which the election is notified.
- iii. Any member holding the highest nursing position (Education/ Service) in the State (Government/ Regulatory/ Statutory bodies) is not eligible to contest for the State/ UT Offices of TNAI.
- iv. Any member who has previously held/ served the national office(s) positions in TNAI shall not contest State/ UT offices.
- v. No TNAI member shall be in the State Executive Committee for more than 20 years. Out of these 20 years, the maximum period for holding the post of President/ Secretary of the branch is up to a maximum of 16 years.
- vi. For those members getting coopted to the state EC, this 20-year period is not restrictive as they do not have voting rights and/or executive powers. Coopted members serve state EC only in advisory capacity.
- vii. Any TNAI member who held 2 consecutive terms (08yrs) as President or Secretary or both the positions in 4 years consecutive term each (total 08 years) as President or secretary shall have a break of a minimum 4 years to contest the post of President or Secretary in the State Branch.
- viii. The current/ previous President or Secretary of the branch shall not contest any other executive positions in the State/UT ie, TNAI members who held the post of President or Secretary of the State/UT branch can contest only for the post of President/ Secretary in the future term subjected to the conditions in the clause number v and vii.

ix. In any case a TNAI member can have a maximum of 16 years as President or Secretary in the State Branch. This is to ensure that no TNAI members shall exceed 16 years term in the National Council.

3. Eligibility for contesting in the various offices of State/UT:

(i) State/ UT President:

Any life member of TNAI working and residing in the State/UT branch and who served one term (04 Years) as a State executive member at any time in the State/UT is eligible to contest for the post of President of the State/UT Branch.

(ii) State/ UT Secretary:

- a. Any life member of TNAI working and residing in the State/UT branch and who served as State executive for one term (04 Years) at any time in the State/UT is eligible to contest for the post of Secretary of the State/UT Branch.
- b. The office of the Secretary is reserved for female TNAI life members only.

(iii) State/UT Vice President:

Any life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of Vice President of the State/UT Branch.

(iv) State/ UT Joint Secretary

Any life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of Joint Secretary of the State/UT Branch.

(v) State/ UT Treasurer

- a. Any life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of Treasurer of the State/UT Branch.
- b. The office of the State/ UT Treasurer is reserved for female TNAI life members only.

(vi) State/ UT SNAI Advisor

- a. Any life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of SNAI Advisor of the State/UT Branch.
- b. The office for the State/ UT SNAI Advisor is reserved for Nursing faculty working and residing in the respective state only

(vii) State/ UT Chairperson- Nursing Education and Research Section

- a. Any life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of Chairperson- Nursing Education and Research Section of the State/UT Branch.
- b. The office for the State/ UT State/ UT Chairperson- Nursing Education and Research Section is reserved for Nursing faculty working and residing in the respective state only

(viii) State/ UT Chairperson- Programme committee

Any life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of Chairperson- Programme committee of the State/UT Branch

(ix) State/ UT Chairperson- Membership Committee

Any life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of Chairperson- Membership committee of the State/UT Branch

(x) State/ UT Chairperson- Public Health Nursing Committee

- a. Any life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of Public Health Nursing Committee of the State/UT Branch.
- b. The office of the State/ UT Chairperson- Public Health Nursing Committee is reserved for Community Nurse/Public Health Nurse/ Public Health Nursing officers working and residing in the respective state and working in the Public Health/ Community Health setting.

(xi) State/ UT Chairperson- Nursing Service Section

- a. Any life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of Chairperson- Nursing Service Section of the State/UT Branch.
- b. The office for the State/ UT Chairperson- Nursing Service Section is reserved for Nursing Staff working and residing in the respective state and working in a hospital/clinical setting.

(xii) State/ UT Chairperson- Socio-Economic Welfare Committee

Any life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of Socio-Economic Welfare Committee of the State/UT Branch.

(xiv) State/ UT Chairperson- LHV/ ANM

- **a.** Any associate life member of TNAI with 05 years of TNAI membership may submit a nomination for the post of LHV/ ANM of the State/UT Branch.
- b. The office of the State/ UT- LHV/ ANM is reserved for female TNAI associate life members only.

4. Common Instructions regarding nomination for the various posts in the State/ UT Branches of TNAI.

- i. A member filing nomination shall be a member working and residing in the respective State/UT branch of TNAI. If the candidate is working, the place of work shall be in the same State/ UT area. An exception may be given to the members living in the NCR region of Delhi but working in the NCT of Delhi. In such cases, the members are not permitted to transfer the membership for 04 years. Also, the member shall give an affidavit to that effect to the RO
- ii. The nomination form shall be **filled and completed by the candidate** i.e. with the complete address pin code and TNAI number of the candidate along with the consent and declaration duly signed. The nomination form shall be proposed and seconded by the TNAI member
- iii. The nomination form submitted shall be supported by a self-attested photocopy of the TNAI life membership photo ID card of the contestant, proposer, and seconder.
- iv. The contestant can submit any number of nominations for any one of the office in the TNAI State/ UT Election.
- v. In case of more than one nomination for the same office, the proposer and seconder shall not be the same.

- vi. The proposer and the seconder can nominate only one person for a particular office. In case a proposer and the seconder proposed or seconded more than one office, the earliest application received to TNAI Hqrs will be considered valid.
- vii. The proposer and seconder for a candidate filing nomination shall be residing in the same state or UT as domicile or working and life member of TNAI.
- viii. All valid nominations for the State/UT President and Secretary shall be included in the Provisional Ballot Paper/ Electronic voting device and published in the TNAI bulletin and TNAI website. The order of the names in the nomination sheet shall be as per the **alphabetic order of the first name** of the candidates.
- ix. For other offices the names of the three members having the highest number of nominations shall be included in the Provisional Ballot Paper/ Electronic voting device
- x. All office bearers who have completed the term of office are eligible for reelection for one more term.
- xi. A break of 04 years after two consecutive terms (08 years) is necessary for the State/ UT President/ Secretary to contest for the post of President/ Secretary at the State level.
- xii. A break of 04 years after two consecutive terms (08 year) is necessary for any other executive members of the State/ UT to contest for the any other posts in the State level except for the post of State/ UT branch President/ Secretary.
- xiii. In any post, a member in the State can hold the State offices for a maximum of 16 Years only.
- xiv. Any person who has expelled from a position in State Office, shall not be eligible to contest for any position in TNAI.
- xv. Members who are, or had been involved in litigation with the Association are not eligible to contest election.
- xvi. The office bearers of a dissolved State/ UT branch are not eligible to contest for a term of **FOUR** years.
- xvii. The members holding office positions in TNAI shall not hold office positions in parallel Nursing Organizations (like (trade unions, other associations or societies). For filing a nomination to the TNAI post, the members will have to relinquish the post in other nursing organizations. The accepted resignation letter from the head of the parallel organization shall be submitted to TNAI headquarters through the respective TNAI State/UT Branch
- xviii. The person so elected for a particular office at the State/ UT level shall hold the office for the full term (four years) and shall not contest and cross to another office before completion of the term of their existing elected office.
- xix. The members who are residing outside the Country/ State/ UT shall not be eligible for contesting election.

केरल के बाद अब झारखंड में मंडरा रहा बर्ड फ्लू का खतरा

झारखंड में हालिया प्रकाश में आए बर्ड फ्लू के मामलों ने राज्य सरकार को चौंका दिया है। रांची के शासकीय पोल्ट्री फार्म में बर्ड फ्लू के मामले मिल रहे हैं जिससे झारखंड सरकार चिंता में है। आधिकारिक सूत्रों ने पुष्टि की है कि रांची के एक सरकारी पोल्ट्री फार्म होटवार में 1,745 मुर्गियों सिहत लगभग 2,196 पिक्षयों को मार दिया गया है चूंकि इन सैंपलों में एच5एन1 वायरस पाया गया था।

स्मरण रहे, कुछ ही दिन पूर्व केरल के अलप्पुझा में बर्ड पलू के मामलों ने स्वास्थ्य एजेंसियों को मुश्किल में खड़ा कर दिया था। इसकी उत्पत्ति और प्रसार के बारे में विश्लेषण चालू है। इसी बीच केंद्रीय एजेंसी एनसीडीसी के एक दल ने जनस्वास्थ्य सुरक्षा की दृष्टि से चेरुथाना और एडाथुआ जिलों के प्रभावित स्थलों का दौरा किया तथा रोकथाम उपायों की अनुपालना के बाबत बताया।

बर्ड फ्लू एवियन इन्फ्लुएंजा ए कोटि का वायरस है जो पक्षियों की सांस प्रणाली पर प्रहार करता है, और संक्रमित पक्षी का बचा रहना दुष्कर हो जाता है। इसका प्रसार प्रायः जंगली पक्षियों, और फिर संक्रमित पालतू पक्षियों की छींक, मल या लार के माध्यम से होता है।

अप्रिय तथ्य यह है कि कदाचित बर्ड फ्लू संक्रमित पक्षियों से मनुष्यों में भी फैल सकता है। मनुष्य में बर्ड फ्लू का पहला मामला 2022 में प्रकाश में आया था। मनुष्यों में इसके लक्षण हैं: दस्त, उल्टी तथा विरल मामलों में दौरे पड़ना। इलाज के लिए ओसेल्टामिविर (टैमीफ्लू) कारगर पाई गई है।

Major Health Events of The Month

International Day of Midwife: 5 May

Midwifery is a health care profession in which providers offer care to childbearing women during labour and birth in the postpartum period, and between pregnancies. They also help in care and breastfeeding of the newborn. First to respond when climate disasters hit, the Midwives deliver safe and environmentally sustainable health services & solutions. Hence, the 2024 theme for International Day of the Midwife (IDM) falling on 5 May is Midwives: A Vital Climate Solution.

Earlier, the midwives were hardly trained formally, it was a traditional learning. However, considering their vital role in care of he newborn, they are provided professional training. The International Confederation of Midwives (ICM) recognises that midwives are a vital solution in adapting health systems to climate change, and lowering carbon emissions overall. Healthcare services are estimated to emit around 5 percent of greenhouse gases globally. By offering continuity of care in communities, midwives reduce the need for avoidable travel to health facilities, thereby cutting the carbon footprint of healthcare while ensuring accessibility.

As midwives we might not immediately see ourselves in as a part of the climate solution. At the same time, it is obvious that the midwifery model of care is environmentally friendly. Evidence shows that continuity of midwife care leads to optimal and safe outcomes by using fewer resources, resulting in less medical waste and a reduced ecological footprint. The care we provide as midwives also helps ensure that resources and the time and expertise of obstetricians are more available to women with complex care needs.

World Asthma Day: 7 May

Asthma is a one of the common non-communicable, chronic disease of the lungs characterised by breathlessness, coughing, wheezing and chest congestion. At the instance of Global Initiative for Asthma (GINA), an offshoot of US-based National Heart, Lung and Blood Institute (NHLB), World Asthma Day is organised annually on first Tuesday of May (this year on 7 May) to raise awareness, care and support for those affected by asthma. The main focus of the day is on supporting the persons with asthma. World Asthma Foundation also supports World Asthma Day. The theme set for World Asthma Day 2024 is, Asthma Education Empowers. It affects over 260 million people and causes 450,000 deaths globally every year; most of these are preventable. Although not curable, the symptoms can be controlled so that people with asthma are enabled to live full lives.

GINA provides free resources for members, health care organisations, charities and communities to organise their own awareness activities for World Asthma Day which may include: free asthma screening clinics locally, media advertisements, educating children about asthma in a fun manner.

International Nurses Day: 12 May

Nurses have a track record of serving our loved ones at some of the most challenging times of their lives. Their painstaking and exemplary performance in the dreaded Corona era of 2020 & 2021 has been etched in history. The entire world celebrates the International Nurses Day (IND) on 12 May, the birth anniversary of nursing legend, Florence Nightingale who was born on this day in 1820. The International Council of Nurses (INC), the apex body of nurses at international level, the umbrella organisation guiding and promoting varied commemorative and other programmes. ICN is a federation of 130+ national nurses' associations representing millions of nurses from all parts of the world. The IND theme for 2024 is, Our Nurses, Our Future. The theme underscores

that investing in nurses improves health outcomes and enhances health security globally. The IND activities are organised week-long in most countries.

In India, there is convention of President of India conferring National Florence awards Nightingale every year to select nurses having made outstanding contribution in various fields of Nursing. The selections are made after receiving entries from all over the country. The TNAI honours the distinguished nurses as mark of its IND celebrations. Though mainly planned around May 12 each year, IND activities continue for much of the year by nurses and nurse institutions and organisations.

World Schizophrenia Day: 24 May

Schizophrenia is a chronic brain disorder related to loss of attention, concentration and memory. It is marked by delusions, hallucinations, and immethodical speech due to disoriented thinking and lack of motivation. While there is no definitive cure for schizophrenia, with treatment, most symptoms are found to improve and recurrence can be diminished.

World Schizophrenia Day is commemorated every year on 24 May. It is a day dedicated to raising awareness of the mental illness that affects over 24 million people worldwide; yet hardly a third of them receive treatment. Schizophrenia is highly stigmatised since it's not talked about and lacks accurate representation in the media. World Schizophrenia Awareness Day is observed on to fight against stigma and to make it easier for people to seek different resources to get help. This day is also a tribute to Dr Philippe Pinel, a French psychiatrist, who unchained and let 200 men to be free like other human beings in late 18th century. Some of these were confined due to mental illness for 30 to 40 years.

Various studies have shown that men with schizophrenia lose an average of 15.9 years of life, and women with schizophrenia lose around 13.6 years. Support and treatment can help you to manage one's condition and the impact it has on one's life. The global burden of schizophrenia continues to increase leading to increased burden on health care systems.
