World Mental Health Day (WMHD), observed annually on 10 October since 1992, serves as a reminder of the importance of mental well-being, especially in high-pressure environments like healthcare. The theme for 2024, *"It is Time to Prioritise Mental Health in the Workplace"* resonates profoundly, given that employed adults spend a substantial portion of their lives at work. Research indicates that approximately 40 percent of healthcare workers report experiencing anxiety, depression, or stress, largely attributable to high workloads, long shifts. Alarmingly, nearly 30 percent of nurses are facing burnout. These statistics highlight the urgent need for a supportive work environment that fosters mental wellness. As advocates for health, we must prioritise mental health initiatives within our workplaces and ensure that nurses and healthcare professionals have access to the resources, training, and support necessary to thrive both professionally and personally. This includes implementing stress-reduction programmes, and creating open lines of communication to address mental health concerns.

- i. Date: 5th December, 2024
- ii. Venue: Mohali Club, Mohali Club, Wyndham Hotel & Resorts, Mohali Pind Road, Phase 11, Sector-65, Sahibzada Ajit Singh Nagar, Punjab-160047.

2. Instructions to contestants:

- Any candidate who wishes to withdraw her/his name from the list of contestants shall do so by giving in writing/ email to the National Returning Officer (RO) on or before 30th October, 2024. The name of such a candidate shall not appear in the Final Ballot Paper.
- ii. The RO shall send a copy of the House of Representative (HOR) and Associate House of Representative (AHOR) list to the contestants on **5**th **November, 2024**.
- iii. The contestants have to submit a request to the National Returning Officer for the same.
- iv. Each contestant shall nominate one representative to witness the entire election process (Polling and counting). The name of the representative in the prescribed form shall be submitted to the National RO before 5 pm on 4th December,2024.

v. The representative forms shall be collected by the contestants from the TNAI National Headquarters either physically or through email on or before **3**rd **December, 2024**.

3. The eligible voters are:

- a. HOR selected by the respective branch President & Secretary.
- b. The TNAI National Executive, National Council Members, National Co-Opted Members & National Ex-Officio Members.
- c. Contestants for the various offices.

4. General instruction to voters

- i. No canvassing shall be permitted on the day of the election inside the premises where the election is taking place.
- ii. No electronic gadgets (mobile phones, cameras) are permitted during the voting. If any Voter is carrying a mobile phone, he/she must keep at a designated place so as to ensure that the mobile phone is not used while casting votes.
- iii. No person other than the voters shall be permitted within the area of the polling booth.
- iv. All voters should queue up at the polling station.
- v. Each voter should show their **TNAI Photo Identity Life Membership card to cast** their vote. (The voters who do not have the **TNAI Photo Identity Life Membership card** shall apply for the Photo Identity card two months before the date of election
- vi. The polling officers will check the **Photo Identity Life Membership Card of TNAI**, with the name and membership number of the eligible voter and instruct the members to sign in the digital identification system.
- vii. In case of any doubt of validity of photo/name it shall be checked with Government ID cards like Aadhar/ Election Voter ID.
- viii. The voters will also sign against their name in the eligible voters' list
- ix. The polling officer shall put an identity mark with indelible ink on the left-hand forefinger of the voter.
- x. The voter can ensure that his/her vote is added to the total polled votes by checking display on the indicator board before and after casting the vote.
- xi. After casting the vote, the voter shall leave the hall quietly and participate in the ongoing HOR and AHOR meetings.
- xii. Any in-disciplinary act created in and around the venue of the election or disturbance to the election by the voters/contestants/representatives of the contestants shall be strictly dealt by the returning officer. In such cases, the National RO has the power to take the decisions for disqualifying the person from casting her/his vote.
- xiii. In case of serious violations, the RO shall submit a written report to the National Council through the National President to take further disciplinary action.



- 4. Request for change of the status of membership (transfer of membership from any state branch to Kashmir) will be permitted till 8th November, 2024, 4:30 pm after that, any change of address will not be accepted. After the last date of transfer of membership (08/11/2024), any transfer request will be processed only after the polling and handing over of office bearership to new office bearers.
- 5. Each contestant is requested to submit the name of the representative (who can observe the entire polling and counting process) to the Returning Officer before 08.30 am on 11th November, 2024. The nomination of the representative shall be submitted in the prescribed form with the name and TNAI number of the person nominated as representative. The prescribed form for the nomination of a representative can be obtained by each candidate from the returning officer.
